


The National Carnival Commission generated income in 2014 which was 13% lower than of 2013. This was due mainly to a significant reduction in the subvention received from the Central Government.


In view of this reduction and to improve overall efficiency, stringent Procurement Policies were introduced resulting in savings in the Carnival Expenses of 30% compared to 2013. The ongoing support to the Special Interest Groups (NCBA, PanTrinbago & TUCO) is in relation to the subvention received from the Central Government (2013 = 25%; 2014 = 38%). Management's implementation of budgetary measures has also resulted in signifiant cost reduction in Construction and Dismantling of Facilities (50%). In its quest to strengthen the awareness of the Carnival tradition the National Carnival Commission has expanded into hitherto uncharted areas by supporting the regional celebrations throughout the country. This has resulted in an increase in the costs of 35%.


Further, the NCC sought to strengthen the staff compliment to support the level of improvement in processes, which necessitated the hiring of qualified individuals for 2014 to fill existing managerial vacant positions. This coupled with ensuring that employment was available to as many deserving persons as possible, resulted in the 65% increase in the salaries and wages over 2013.

The National Carnival Commission will continue operating within an organised framework to provide the necessary infrastructure and support for the Carnival celebrations for future years.
